## Remodel/Repair Project at Station 3

Bids for the remodel/repair project for Station 3 have been submitted and are as listed below:

Miradu Construction \$ 59,000.00 Webb Construction \$ 59,400.00 YP Construction \$ 77,000.00

After discussion and review of the proposals, Board member Ray Lopez made a motion to award the contract to Miradu Construction, Board member Johnson seconded. Contract was awarded plus \$ 2,000.00 for permit fees.

## **Storage Building at Station 2**

Bids for the storage building at Station 2 have been submitted and are listed below:

Pacific Buildings \$ 35,706.89 Rosser Buildings \$ 48,585.00

Big Buildings \$34,446.71 (No door included)

After discussion and review of the bids Board member Johnson made a motion to award the contract to Pacific Buildings and allow \$5,000.00 allowance to pay for items that were not included in the bids but necessary to complete the project, Board member Lopez seconded.

#### Portable Toilet at Station 2

Bids have been submitted by 3 vendors as listed below:

Ben Toilet \$ 149.34 per month United \$ 404.44 per month Mate \$ 191.43 per month

Board member Johnson made a motion to accept the proposal from Ben Toilet, Board Chair Heatlie seconded.

#### JPA AMMENDMENT

The City Manager Bill held a meeting on January 29, 2024, to interview candidates for the JPA contract work. Chief Paquette and Board Member Johnson attended and participated in the interview process; the panel chose the firm that they believe is the right fit and it is anticipated that the contract will be awarded in February 27<sup>th</sup> 2024 at the City of Wheatland Council meeting.
